Visiting scholar: Francesca Di Matteo

Francesca Di Matteo is a PhD student at the University of Teramo, Italy and also works for the law firm Sotgiu & Associati in Teramo. She was a Visiting Scholar at the Brussels Privacy Hub from January to March, 2017. We asked her some questions about her visit:

1. What brought you to Brussels and, more specifically, the Brussels Privacy Hub?

I met Hub Co-Director Professor Christopher Kuner during his lessons at the Hague Academy of International Law (2015-Private International Law Session). After his seminar, I shared with him my research project and the intention to spend a period of research abroad in a 'privacy-oriented' environment. This is how I discovered the Brussels Privacy Hub. After that, I also attended the first European data protection law summer school organised by the Hub.

2. In February, you presented at a researchers' gathering on 'The Right to Privacy in the Age of Electronic Surveillance: Reconsidering the Extraterritorial Application of Human Rights Treaties'. What did you gain from this experience?

My presentation at the researchers' gathering has been very useful. I got interesting and stimulating feedback on the structure of my doctoral thesis, and it made me more confident with the weak points of it and also with the possible alternative perspectives.

3. How would you summarise your time with the Brussels Privacy Hub?

It has been a great professional (and human) experience, definitely.

GDPR Workshop Series


24 April 2017 • Health and Well-being Apps - Problematic Legal Issues

The phenomenon of 'appification' has made major inroads in the area of health and well-being. Each of these types of 'app' raises various legal issues, from questions associated with privacy and data protection to issues of liability that could arise if such apps were to be used as medical devices.
